

HOUSEHOLD HAZARDOUS WASTE

ACCEPTABLE

(if the container is empty it should go in the garbage, do NOT register these materials)

Aerosol Cans (spray paint, hair spray, etc.)	Asbestos (Asbestos – Friable, Non-Friable)
Batteries, Dry Cell (Batteries, Alkaline, household)	Batteries, Lead Acid (Batteries, automotive tractor)
Caustic Alkali/Bases (Cleaners, floor, all-purpose, Drano, liquid shoe policy)	Combustible Liquid (Resins adhesives, glues, grout)
Cons, Organic Liquid (Soaps, rinse water, etc.)	Compressed Gases (Propane, butane, fire extinguishers, etc.)
Corrosives (Acid) (Acids, metal polish, naval jelly, Solid shoe polish)	Construction Debris (Sheetrock, wood, shingles, carpeting)
Fertilizers, Liquid (Plant food, Lawn Grow, etc.)	Driveway Sealer (Driveway sealer, roof cement, tar, etc.)
Flammable Liquid (Thinners, solvents, mineral spirits, Turpentine, etc.)	Ethylene Glycol (Antifreeze)
Florescent Tube (Florescent tube, lighting)	Fertilizers, Solid (Turf Builder, Lawn Gro., Nitrogen Plus, etc.)
Grease (Auto, cooking)	Flammable Solids (Flares)
Mercury (thermometer, barometer, pure liquid, etc.)	Flammable Solids (Mothballs, Stenos)
Paint, Flammable (Oil-base, stains, etc.)	Gasoline (Gasoline, leaded, unleaded)
